# UIPM / WORLD OBSTACLE JOINT STATEMENT



Ever since the UIPM Obstacle Task Force (OTF) released its most recent statement on 25 October 2025, integration talks have taken place on a regular basis between representatives of UIPM and FISO (World Obstacle).

Both Federations remain fully committed to the proposed integration of FISO within UIPM, following the approval in principle provided by FISO's member federations at the 2025 World Obstacle Congress in Sweden. Subsequent meetings have reinforced the two organisations' shared commitment to concluding this integration for the mutual benefit of all member federations and their communities.

All National Federations of UIPM and FISO received a written update on the integration process today. On March 15, the Obstacle NFs will gather in Nice, France, for the 12th FISO and World Obstacle General Assembly, where they will vote on the dissolution of FISO. The General Assembly will be preceded by a meeting of the OTF, also in Nice, on March 14.
