3. Type of Allocation of Quota Places:

The quota place is allocated to the athlete by name. NOCs with more than two (2) qualified athletes have the authority to decide which two (2) qualified athletes they will enter.

C. ATHLETES ELIGIBILITY

All athletes must comply with the provisions of the Olympic Charter currently in force, including but not limited to, Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions). Only those athletes who comply with the Olympic Charter may participate in the Olympic Games.

Six (6) quota places will be allocated via the UIPM Olympic World Ranking List as at 14 June 2021 to the first six (6) athletes not already qualified through the above competitions.

If one or more of the six (6) athletes has already qualified at a Continental Championships, the 2019 World Cup Final, the 2019 UIPM World Championships, or the 2021 UIPM World Championships, the athletes ranked 7th and thereafter according to the UIPM Olympic World Ranking List (as of 14 June 2021) will be considered qualified by the UIPM Olympic World Ranking instead.

The UIPM Olympic World Ranking List comprises the following eligible ranking competitions taking place during the period 1 June 2019 to 13 June 2021.

1. **UIPM Major Competitions**

- 2020 UIPM Pentathlon World Cup Cairo (Feb 25-Mar 1)
- 2021 UIPM World Cups Series, including 2021 UIPM World Cup Final
- 2021 UIPM World Championships

2. Continental Qualifications

- 2019 European Championships (Aug 6-11)
- 2019 Pan American Games (Jul 26-Aug 11)
- 2019 Asia/Oceania Championships (Nov 11-21)

3. Ranking Competitions*

- 2019 International Belarus Open (Jul, 4-7)
- 2019 International Polish Open (Sep, 12-15)
- 2019 International Jury H. Memorial Kyrgyzstan Open (Sep 26-29)
- 2020 International Budapest Indoor (Jan 29-Feb 2)

HOST COUNTRY PLACES

The Host Country is guaranteed one (1) quota place per gender, if not otherwise qualified.

TRIPARTITE COMMISSION INVITATION PLACES

Two (2) Tripartite Commission Invitation Places are made available to eligible NOCs at the Tokyo 2020 Olympic Games in each gender.

On 1 October 2019, the International Olympic Committee will invite all eligible NOCs to submit their requests for Tripartite Commission Invitation Places.

The deadline for NOCs to submit their requests is 17 January 2020 (following the postponement, NOC may submit new applications for replacements, up until 31 January 2021). The Tripartite Commission will confirm, in writing, the allocation of invitation places to the relevant NOCs after the end of the qualification period for the concerned sport.

Detailed information on Tripartite Invitation places is contained in the "Games of the XXXII Olympiad, Tokyo 2020 - Olympic Games Tripartite Commission Invitation Places - Allocation Procedure and Regulations".





E. CONFIRMATION PROCESS FOR QUOTA PLACES

Following each qualification competition, UIPM will publish the results on its website www.pentathlon.org The qualification system closes at midnight Monaco local time on 14 June 2021. On 15 June 2021, the UIPM will inform the respective NOCs of their allocated quota places. The NOCs will then have 6 (six) days, until 23:59h (Monaco local time) on 21 June 2021, to confirm if they wish to use these quota places, as detailed in paragraph **H. Qualification Timeline.**

F. REALLOCATION OF UNUSED QUOTA PLACES

On 22 June 2021, the UIPM will inform the respective NOCs of re-allocated places. The NOCs will then have 6 (six) days, until 23:59h (Monaco local time) on 28 June 2021, to confirm if they wish to use these quota places, as detailed in paragraph **H. Qualification Timeline**. Further reallocation, if necessary, will then take place until the reallocation period closes on 29 June.

REALLOCATION OF UNUSED QUALIFICATION PLACES

If a quota place allocated is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated to the next highest ranked athlete on the UIPM Olympic Ranking List as at 14 June 2021 not already qualified. The minimal continental quota, as outlined under D. Qualification Pathway/ Qualification Competition, must be respected. In case of necessary reallocation for a continental quota place, the next highest ranked athlete on the UIPM Olympic Ranking List as at 14 June 2021 not already qualified from the respective continent will be qualified.

REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused Host Country Place(s) will be reallocated to the next highest ranked athlete on the UIPM Olympic Ranking List as at 14 June 2021 not already qualified.

REALLOCATION OF UNUSED TRIPARTITE COMMISSION INVITATION PLACES

If the Tripartite Commission is not able to allocate a Tripartite Commission Invitation Place, it will be reallocated to the next highest ranked athlete on the UIPM Olympic Ranking List as at 14 June 2021 not already qualified.
