1. Summary of Bath Para Laser Run and any lessons learnt (Nic and Radka) Well done again!

NR took a word and presented whole process/study/project that led to successful organization of Para Laser run in Bath. She spoke about reasoning behind creating an "recruiting" event that would not need the official classification — National Para Laser sport. Key was to stimulate awarness about what Para Pent Sport was. She described the patway to the event itself composed from attendace on meetings with LOC, Discover events , participation on inclusive festival, classification weekend and classifier training . All turned out in successful.

The revision of Para Sport Regulations shall be done more regularly, also in line with current terminology used and with evolution of athlete community.

Issues with UIPM Portal has been raised by NR as a limit having impact on effectivness of event organization and how it could be solved.

TV coverage of the event was perceived by everyone as successful. NR also summarized pro&contra experiences from LOC and organization staff and volunteers as best practice advise for new season organizers.

MD left the meeting.

2. Bali Biathle Triathle World Para Champs - updated (Andrew Radka)

AC spoke about invitation letter been sent to athletes, communicating the limits of the venue which limited the classes opened. He presented the interest received from few AUS-Oceania countries to take part in the event. He introduced the limits and presented Risk assessment for event - sand, open water having impact.

RZ summarized the output from recent communication with NFs interested to take part in a competition

NR opened the commission discussion about the running surface variability in Bali BT/TT event

AC spoke about the Freemason funding opportunities and about his experience from search, study grants and other ideas emphasizing also the brainstorming from other members. NR joined discussion raising the idea of specific PhD study program in joint knowledge partnership with some University (for example LIMU)

9. Recheck against para strategic plan (all)

RZ and AC summarized the vision of Para Competition pyramid and about vision of how to get more countries participating . The fact that NFs do not register athletes on portal unless they go to concrete UIPM Para competition (with exception of Egypt)has been discussed and how to communicate this need of licence.
